What happens when we have safeguarding concerns about your child

This leaflet will give you an overview of the safeguarding process we always follow to ensure that children in our care are kept safe where there are concerns about neglect or abuse.

We understand that this process can be a worrying time for you, but we will explain everything and listen to you and your child's concerns.

As this is a legal process, it is very important that you understand what we are doing and why. We hope that this information is helpful so please ask as many questions as you wish. We are here to help.

# The Children's Safeguarding Team and all staff at Lancashire Teaching Hospitals are guided by the following key principles:

- Children have the right to be safe and should be protected from all forms of abuse and neglect
- Safeguarding children is everyone's responsibility
- It is better to help children and their families as early as possible, before issues escalate and can become more damaging
- Children and families are best supported and protected when everybody works together

### What is safeguarding?

Safeguarding is the action that is taken to promote the welfare of children and protect them from harm. It is important that people work together to keep children safe.

### Safeguarding means

- Protecting children from abuse
- Preventing harm to children's health or development
- Ensuring children grow up safely and well cared for

# Why do we safeguard?

Lancashire Teaching Hospitals NHS Foundation Trust is committed to protecting children and young people from harm, abuse or neglect.

Concerns about your child's safety or welfare have been raised. We have a legal duty to respond to these concerns and our job is to help work out if there is a reason for those concerns and if we can understand or resolve these by asking you and other agencies for help.

# What is our responsibility in safeguarding children?

The Children Act 1989 and 2004 makes it a legal duty for all staff to protect all children under the age of 18 from the risk of significant harm.

If there is a concern about the safety or welfare of your child, Lancashire Teaching Hospitals NHS Foundation Trust will follow the child protection policies and procedures as set by Lancashire Children's Safeguarding Assurance Partnership.

### Consent

You will be asked to confirm you have 'parental responsibility' and then to provide consent for us to undertake any assessments that are needed.

We will also make sure you fully understand what is happening with each process and why.

We may also ask your child for their consent as long as we feel they fully understand what is involved.

However, there are occasions when your consent is not legally needed, because the law requires us to share certain information with children's social care or the police if it is in your child's best interests.

# The process

An experienced children's doctor will take a history of events and may complete a physical examination. The doctor may feel that further tests or photographs are needed to help get a better understanding for our concerns.

If there is a concern about the safety or welfare of your child, we will share our information with children social care and the police so, with their support, we can ensure that your child receives the best help or protection needed.

### **Child protection**

Child protection aims to keep children safe where there is a serious risk of harm.

Children's social care are always informed if we follow this process as they have a legal duty to investigate our child protection concerns.

### **Child protection medical examination**

A senior doctor may need to complete a 'child protection medical examination' to check for any signs of harm to your child.

If a child protection medical examination is required, you will be provided with further information about this process.

# Working in partnership to safeguard your child

We understand that it is upsetting to have concerns raised about your child's safety and wellbeing. We always try to work in partnership with parents and carers to offer support. We ask that you cooperate with us, and the other agencies involved, in the best interests of your child.

### The rights of the child are:

- To be safe and protected from harm, abuse & neglect
- To be heard and have their views & feelings considered
- To appropriate confidentiality
- To be protected and supported
- To be informed and updated according to their age and understanding
- To ask for explanations and to raise concerns
- To consent or refuse medical examinations as long as they fully understand what is involved
- To have an interpreter if needed
- To have a chaperone

### Your rights are:

- To be heard and supported
- To be kept informed and involved
- To ask for explanations and appropriate confidentiality
- To seek legal advice and complain
- To have an interpreter if needed
- To request a chaperone

# Looking after & sharing information about your child

In order for us to gather and share information we will ask for your consent to contact your child's GP, health visitor, school nurse or other agencies that may be of help.

# Who do I speak to for further information?

This leaflet only gives general information. You can always discuss the individual treatment of your child with the nurse looking after your child and the consultant paediatrician in charge of your child's care.

If you need more information about the child protection process, please contact the social worker allocated to your child's care, if applicable.

Please do not rely on this leaflet alone for information about your child's treatment. Working in partnership to safeguard your child, we understand that it is upsetting to have concerns raised about your child's safety and wellbeing.

We always try to work in partnership with parents and carers to offer support. We ask that you cooperate with us and the other agencies involved in the best interest of your child.
