# Why become a Governor?

How would you like to be the voice for your community and have the chance to make a difference?

Do you believe that the views of members should be heard at every level of the Trust, and think that you would be able to understand and share these views with the Council and Board of Directors?

Governors are essential in making sure that the views of our wider community are considered in providing and developing our hospital services.

The most important thing you will need to be one of our Governors is enthusiasm for the role, rather than any specific skills or knowledge. You should care about our patients, staff and the services the Trust provides, and you should wish to bring the knowledge and experience of members into discussions and decisions about the direction of the Trust.

All Governors have a vital role to play and the role should be satisfying and challenging.

### The role of a Governor

The Governor role provides an opportunity for members to have a voice.

As a Governor, you will inform the Council of Governors of members' views and support the Trust Board in understanding widely held views of members. This could be on topics such as patient experience and or quality of services.

The role of the Governor does not duplicate the work of other staff representatives (e.g. Trade Union representatives or professional bodies) and Governors do not deal with specific individual issues for the public such as complaints which are dealt with by formal staff representatives. It is about listening to public feedback and keeping abreast of feedback themes.

To find out more and if it is right for you then come along to our virtual prospective governor information workshops.

You will get a chance to hear from Electoral Reform Services about the election process, learn more about the role and the expectation of a governor, meet existing governors, and hear about how you can make a difference.

# **Support, Training and Induction Programme for Governors**

The Trust recognises the important role of Governors and will support them to work effectively.

The Office of the Company Secretary works closely with Governors to provide them with access to administrative resources and information.

The Office of the Company Secretary will be the first point of contact and support for the Governors.

All Governors are expected to attend an induction programme which will assist Governors in carrying out their role.

It is mandatory for all new Governors to participate in the induction programme. All Governors are expected to adhere to the Trust's policies and procedures and will be bound by the Trust's Code of Conduct for Governors.

Specific issues relating to confidentiality must be adhered to as defined in the Constitution.

The nomination form is only short and will have space for prospective Governors to write a short statement (50 words) about why you think you should be selected. You will also have 200 words to describe what skills and experience you believe you can bring to the role.

The information supplied by candidates is published and will accompany a ballot paper, should the seat be contested.

We will not alter or correct your statement in any way. It will be reproduced word-for-word so remember to check it carefully. Any statements of longer than the maximum word count are stopped at the maximum, even if this ends mid-sentence.

# Silas Nicholls begins role as Chief Executive

On Tuesday 8th January 2024, we were delighted to see our new Chief Executive, Silas Nicholls, begin his role with the Trust.

Silas joins Lancashire Teaching Hospitals as an experienced Chief Executive and NHS leader who has held a wide range of senior executive positions across the North West.

Silas's first Chief Executive post was at the University Hospital of South Manchester NHS Foundation Trust (UHSM) in 2016, having joined the organisation two years earlier as Chief Operating Officer. Previously, he has been Chief Executive of Southport and Ormskirk Hospitals NHS Trust and joined Wrightington, Wigan and Leigh NHS Foundation Trust in 2019 as Chief Executive, continuing in this role until joining Lancashire Teaching Hospitals.

While we welcome Silas to the Trust, we also thank Faith Button for her spell as Interim Chief Executive following Kevin McGee's retirement from the NHS after 38 years. Faith recently confirmed she will be taking up a new role at NHS Birmingham and Solihull Integrated Care Board (ICB) as Chief Delivery Officer in March, and our best wishes go to her in her new position.

# Lancashire and South Cumbria New Hospitals Programme – have your say!

As you may know, we have a once-in-a-generation opportunity to transform our region's hospitals. By creating a network of brand new and refurbished facilities, we'll help local people live longer, healthier lives.

In May 2023, the Government announced a record investment of more than £20 billion, ring-fenced for the next phase of the national New Hospital Programme, which brings proposals for new cutting-edge hospital facilities for Lancashire and South Cumbria a step closer.

As part of these plans, it would see two new hospitals to replace Royal Preston Hospital and Royal Lancaster Infirmary as part of a rolling programme of national investment in capital infrastructure beyond 2030.

To ensure those who use our hospitals are at the heart of the decisions being made, the national New Hospital Programme are running a series of engagement workshops to hear about your experiences using hospital services to help improve the designs and layout of future hospitals.

They are also working with hospital clinicians, estates teams, digital — information and technology — and workforce colleagues, health regulators, the Royal Colleges, and other professional bodies, as well as public and patient experience groups, to ensure the best designs and clinical standards for all our hospitals are created.

The next virtual workshop is for those who have recent experience of using hospital car parks and will take place on Tuesday 30th January 2024. Those interested have until 23rd January to register for a session at either 1pm-2.30pm or 6pm-7.30pm.
